The Medical Assessment and Rating Board has received online application (Part-1) seeking permission for Sir, student intake in Under Graduate (BHMS) course with student intake of 75 seats in UG (BHMS) course for the academic year 2022-23. As per provision of NCH Act, 2020 Medical Assessment and Rating Board for Homoeopathy (MA&RBH) has been constituted with the mandate to grant permission for student intake to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform that Part-1 Performa and all the relevant documents submitted by your college were examined as per the existing regulations.

- On scrutiny and careful consideration of your documents and further observations of the Board, the following shortfalls to be addressed for granting permission for student intake in UG (BHMS) course for the academic year 2022-23:
  - A. Hospital Staff: House Physician 01 available against the requirement of 02.
  - B. Teaching Faculty: Dr. Shraddha Sudhir Bhadane (Lecturer, Forensic Medicine and Toxicology): Affidavit not provided.
  - C. Miscellaneous:
    - a) ECG register not provided.
    - EPF e-challan of only 10 members provided.
  - That the applicant has set up the Homoeopathic Medical College and teaching Hospital with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take urgent and time 4. bound steps to fulfill the above requirements for conducting Under Graduate course in Homoeopathy
  - After considering the provisions of NCH Act, 2020 the permission of the Medical Assessment and Rating Board for continuing admission is granted to Kisan Dnyanoday Mandal Homoeopathic Medical College Maharashtra, Nimzari Road Shirpur, Dhule- 425405 with intake capacity of 75 seats in undergraduate course (BHMS) for the academic year 2022-23.
  - The College Principal is directed to fulfill all deficiencies within a period of 30 days and an undertaking shall be submitted in this regard by the Controlling Authority of the College within a period of 07 days from issue of this letter of
  - As per section no. 43 of the NCH Act 2020, vide letter no. Y-11011/4/2022-EP-III dated 14.10.2022, Central permission. Govt. has taken a policy decision that all admission shall be through NEET only with qualifying marks 50 percentile. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET). Any

admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed.

- The counseling for seats under All India quota shall be conducted by respective counseling Authority of State/ UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State / UT. 100% Under Graduate & Post Graduate seats of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The Counseling of seats under All India Quota shall be conducted by Central Government.
- The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is

It is mandatory for the college to apply to the Central Council through Central Govt. and ensure that <u>Permitted/Not Recognized qualifications are enlisted in "Recognized Qualifications"</u>, failing which <u>University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such courses.</u>

You are requested to comply with the above mentioned deficiencies within 3 months without fail and submit compliance report.

#### Important Note:

- 1) The Continuation / Extension of Affiliation is issued for the Academic Year 2022-2023 subject to the permission of National Commission for Homoeopathy/Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The college is not authorized to admit the students for 1st year of the course until receipt of permission of the National Commission for Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi.
- The admission shall be done only through the Competent Authorities.
